Grass Cutting

- The Contractor shall provide, service, and maintain their own equipment to complete the mowing of identified municipal areas.
- On a weekly basis (7 to 10 days weather dependent) from mid-May through mid-September, the Contractor shall mow municipal grass areas as identified.
- This work is estimated at 225 hours for the period of mid-May to mid-September.

Parks Cleaning and Maintenance

- On a weekly basis, the Contractor shall remove litter and garbage from identified trails and Day Parks in the Summer Village of Crystal Springs.
- On a weekly basis, maintain plants and flowers, trimming, Day Park / Pavilion cleaning and bookings.
- This work is estimated at 105 hours for the period of mid-May to mid-September.

Garbage Container Return

• The Contractor will return individual garbage bins from the street onto the owner's property as per the following the schedule:

Road Signage and Miscellaneous

- The Contractor shall change sign Road Ban signs as directed.
- Signage shall be provided by the Summer Village.
- Contractor shall install and remove buoy's upon request of Summer Village

HOURS OF WORK:

The position will commence on or about May 3, 2021. The hours of work will vary based on the scope of work identified above.

- 1. The scope of work has been based on historical information and is weather dependent. Each task will require a minimum of weekly/monthly maintenance and attention.
- 2. The Contractor shall submit an invoice on a regularly basis (monthly) in the format the Summer Village requires.
- 3. Payment from the Summer Village to the Contractor will be made within 30 days of receiving the Contractor's invoice.
- 4. The Contractor shall be remunerated monthly based on the following schedule:
